The Management has identified as a critical success factor the adoption of a Company Policy which, through constant attention to the professionalism of human resources and the effectiveness of technical and organisational processes, is proposed as a guarantee tool for the achievement of strategic objectives and the continuous improvement of the company performance: customer satisfaction, safeguard of the work activity, compliance with the applicable mandatory regulations in terms of product manufacturing and health and safety at work.

The achievement of these objectives is the long-term aim of the Board of Directors. Every year, on the occasion of the Management Review, these goals are monitored through specific operational objectives grouped in the document "Mod. 004 - X-Matrix", the achievement of which is periodically verified.

In particular, the Management of the Company BERTO E.G. ensures that the Company Policy:

- is appropriate to the needs and requirements of the Company itself and the requirements of the customers;
- is documented, implemented and made operational through the involvement of the staff at all levels and functions concerned, according to the procedures laid down in the Company Management System;
- is oriented towards the achievement of requirements and continuous improvement;
- provides a path for determining and reviewing Quality and Safety objectives;
- is communicated, understood and implemented by everyone within the organisation;
- is regularly reviewed in order to check its adequacy;
